Each vendor is required to pay for their space in full to reserve your spot. We will do our best to accommodate any special needs but, remember that spaces are limited, and all spaces will be awarded on a first reserved, first paid basis. Your application is subject to approval by the Rallys R Us staff and will not be considered until it is received along with payment.

Rally R Us is an all weather event, and no refunds will be issued on account of weather. Each vendor is required to provide their own sun/rain protection.

Rallys R Us does not/can not guarantee that vendor's merchandise will be bought by attendees, and therefore does not/can not guarantee a profit.

This is an adult event, meaning no one under the age of 21 will be admitted. There will be no exceptions, including vendors, so please make sure that your employees are 21 or over and that they have a valid ID. Rallys R Us reserves the right to verify identification of all persons and to deny admittance at its sole discretion. Wrist bands will be provided upon entrance to event and must be worn for the duration of the event. Each person registering as a vendor must sign in at registration table at front gate, have valid ID, and will receive wrist band at that time.

Rallys R Us strictly prohibits the display or sale of firearms, hard core pornography, controlled substances, and open air prostitution.

VENDORS ARE NOT ALLOWED TO SUBLET THEIR SPACE

Vendors will be issued 2 vendor passes with their registration. Additional passes may be purchased at a discounted rate with your vendor space. Please call our office to obtain extra passes. Each person in attendance will be required to have a gate pass with **NO EXCEPTIONS**.

Rallys R Us will **NOT** sign for any packages or deliveries. Each vendor must personally sign for their merchandise when the delivery truck arrives.

All vendors will be responsible for setting up and tearing down their own displays. Each vendor is responsible for **CLEANING THEIR VENDOR AREA AND PLACING BAGS OF TRASH IN THE DUMPSTERS PROVIDED**.

Vendors can begin arriving at the rally on Wednesday before the rally at 8:00 am. Please do not arrive any earlier as you will not be admitted into rally until 8:00am.

Vendors will have a designated area to park their RVs and vehicles. The designated area is close to the vendor sites for your convenience. No vehicles or trailers will be allowed behind your space. Only one vendor is allowed per vendor space. **THESE VENDOR SPOTS ARE SELF-CONTAINED**.

ALL FOOD VENDORS ARE REQUIRED TO CONTACT THE STATE OF TEXAS DEPARTMENT OF HEALTH SERVICES TO OBTAIN A FOOD VENDOR PERMIT. A COPY OF THE PERMIT MUST BE DISPLAYED AT ALL TIMES DURING THE EVENT. Tammy Honea 903-657-3832. She is out in the field frequently so leave a message if she does not answer.
